Pupil Withdrawal Form Update and Next Steps

ADE Accountability will be working with our Title I Program in completing audits on the "Official Pupil Withdrawal Forms". A link to that document, which includes "Guidance and Procedures", can be found here.

Using the proper withdrawal codes ensures the accurate reporting of graduation, dropout, and persistency rates. Schools that serve students in grades 6 through 12, may want to review the, "<u>Graduation, Dropout, and Persistence Rate Technical Manual</u>" to understand how exit code effect these measurements.

During the pandemic, there has been an uptick of students being withdrawn to be home schooled. The guidance to apply these codes is as follows:

W9/S9 — Home Schooled Students: This code is used for students who withdraw to be taught at home. A.R.S. \$15-802(B)(3) allows a student to be taught at home after certain requirements are met. The parent must file an affidavit with the county school superintendent that the child is attending a regularly organized private or home school. Official written documentation is required to apply this code.

Documentation may include a letter of withdrawal or other written confirmation from the parent or guardian, or the affidavit filed with the county school superintendent.

A.R.S. \$ 15-827. Presentation of Withdrawal Form

A. A pupil who enters a school shall present to the principal of the school a properly executed withdrawal form if such pupil previously attended another school in this state.

B. The withdrawal form prescribed by subsection A shall be prepared and distributed by the office of the superintendent of public instruction. The withdrawal form shall in addition to any other data required by the superintendent of public instruction contain space for the reason for withdrawal and the signature of an official of the school from which the pupil has withdrawn.

Audits will not begin until we have gathered additional information from the field regarding practices and field's understanding of the withdraw form.



Recap and Update from September Board Meeting

2020-2021 Assessment and Accountability

Federal and state laws require Arizona to adopt and implement a statewide assessment to measure student achievement in English Language Arts, Mathematics, and Science. To date, the U.S. Department of Education has indicated it will not issue waivers to statewide assessment requirements as it did in the Spring of 2020.

State law requires ADE, with approval from the Board, to establish an A-F Accountability System and award letter grades by November 1st of each year. Understanding that these requirements are currently still in place, and in light of the impact of COVID-19 on schools during the 2020-2021 school year, the Board took the following steps:

- 1. Shortened the length of the statewide assessments in the Spring of 2021.
- 2. Directed ADE to use the same test from 2019 for grades 3-8 to more accurately compare pre- and post-COVID-19 student achievement and help the state better evaluate the stability of the data.
- 3. Began an analysis, with its technical advisory committees and ADE, of the data used to calculate A-F letter grades. The analysis, modeled after national work, consider each component of the Accountability System in light of COVID-19 in the following areas: completeness, consistency, impact, and practicality. The analysis will guide the Board's position on the viability of the A-F Accountability System in the 2020-2021 school year.

Self-Reported Data

The window for self-reported data (CCRI, On-Track to Graduate, Credits Earned) from the 2019-2020 school year has been reopened to allow schools to submit their 2019-2020 Data.

AzSCI

The AIMS Science bonus point will be replaced with an AzSCI percent tested bonus point. As a reminder, this action is necessary due to the elimination of AIMS Science in the 2020-2021 school year to reduce testing and retire an antiquated assessment.

A-F Self-Reporting Data Application Reopening on ADEConnect

On September 28th, the AZ State Board determined that the A-F Self Reporting Data application should be reopened in order to provide schools with additional time to submit their self-reported data components (CCRI, Credits Earned, and On-Track to Graduate). We strongly encourage schools to submit their data in order to verify and check for accuracy as well as for future accountability purposes.

At this time, the application has been officially reopened and can be accessed through the ADEConnect home page. It will close on **December 23rd, 2020 at 5:00 p.m.**. After this deadline, schools will no longer be able to submit data for the 2019-2020 school year.

Because the A-F Self Reporting Data application is new this year on ADEConnect, a guide for accessing the application and submitting data has been created and can be downloaded here.
