### PROGRAM DESCRIPTION

The **Law and Public Safety** program prepares individuals to apply theories and practices of organization management and criminal justice to the administration of public law enforcement agencies and operations. The **Law and Public Safety** program includes instruction in law enforcement history and theory, operational command leadership, administration of public police organizations, labor relations, incident response strategies, legal and regulatory responsibilities, budgeting, public relations, and organizational leadership.

The **Law and Public Safety** Career and Technical Education program is delivered as a coherent sequence of courses designed to offer students knowledge and skills that meet the needs of the workplace. The Professional Skills developed by business and industry leaders across Arizona are integrated throughout the program. **Law and Public Safety** students develop leadership, social, civic, and career skills through participation in the state-recognized Career and Technical Student Organization, SkillsUSA.

The **Law and Public Safety** instructional program prepares students for entry-level employment, further training, and/or postsecondary education for these and other occupations: Criminal Justice and Law Enforcement Teacher, Investigation and Security Service, Intelligence Analyst, Loss Prevention Managers, Protection Officer, and Asset Protection Specialist
