PROGRAM DESCRIPTION

The **Therapeutic Massage** program prepares students to provide relief and improved health and well-being to clients through the application of manual techniques for manipulating skin, muscles, and connective tissues. The **Therapeutic Massage** program includes instruction in Western (Swedish) massage, sports massage, myotherapy/trigger point massage, myofascial release, deep tissue massage, cranio-sacral therapy, reflexology, massage safety and emergency management, client counseling, practice management, applicable regulations, and professional standards and ethics.

The **Therapeutic Massage** program is designed and delivered as a coherent sequence of school-based and work-based supervised learning. The Professional Skills developed by business and industry leaders across Arizona are integrated throughout the program. The **Therapeutic Massage** students develop leadership, social, civic, and career skills through participation in the Career and Technical Student Organization HOSA (Future Health Professionals).

The **Therapeutic Massage** instructional program prepares students for entry-level employment, further training, and/or post-secondary education for these and other occupations: Licensed Massage Therapist and Licensed Medical Massage Therapist
