

# The EL72 – ELP Roster Report

#### LOCATION OF REPORT

The EL72 – ELP Roster Report (EL72 Report) is in the Arizona Department of Education's ADEConnect dashboard under the Assessments application menu. An ADEConnect account is required with the role of **AZELLA District Test Coordinator** (one per district) or with an **ELL role or title** to be able to access the report.

#### PRINTING THE REPORT

The EL72 Report is available as a PDF or CSV file. It is recommended that this report be printed from ADEConnect in **Landscape Orientation**.

#### DESCRIPTION OF REPORT

The EL72 – ELP Roster Report displays all the English Language Proficiency (ELP) tests, Placement and Reassessment, that were administered to students by the LEA/School during a Fiscal Year. The EL72 Report does not vary based on changes in enrollment; therefore, the student will always appear in the report of the LEA/School where they were tested. This is a Fiscal-Year based annual report. The current plus 3 prior fiscal years are available for viewing and downloading. The annual report is updated regularly throughout the school year and reflects all ELP test results as they are uploaded into ADE's student record system. Student data is reported by district, school, and grade.

## <sup>3</sup>Overall Proficiency Level

A determination of Proficient for Overall Proficiency Level on the <u>AZELLA</u> Placement and Reassessment Tests requires the Total Proficiency scale score to be greater than or equal to 1000 <u>**AND**</u> a domain proficiency level of Intermediate or Proficient in all 4 domains: Listening, Reading, Writing, and Speaking.
