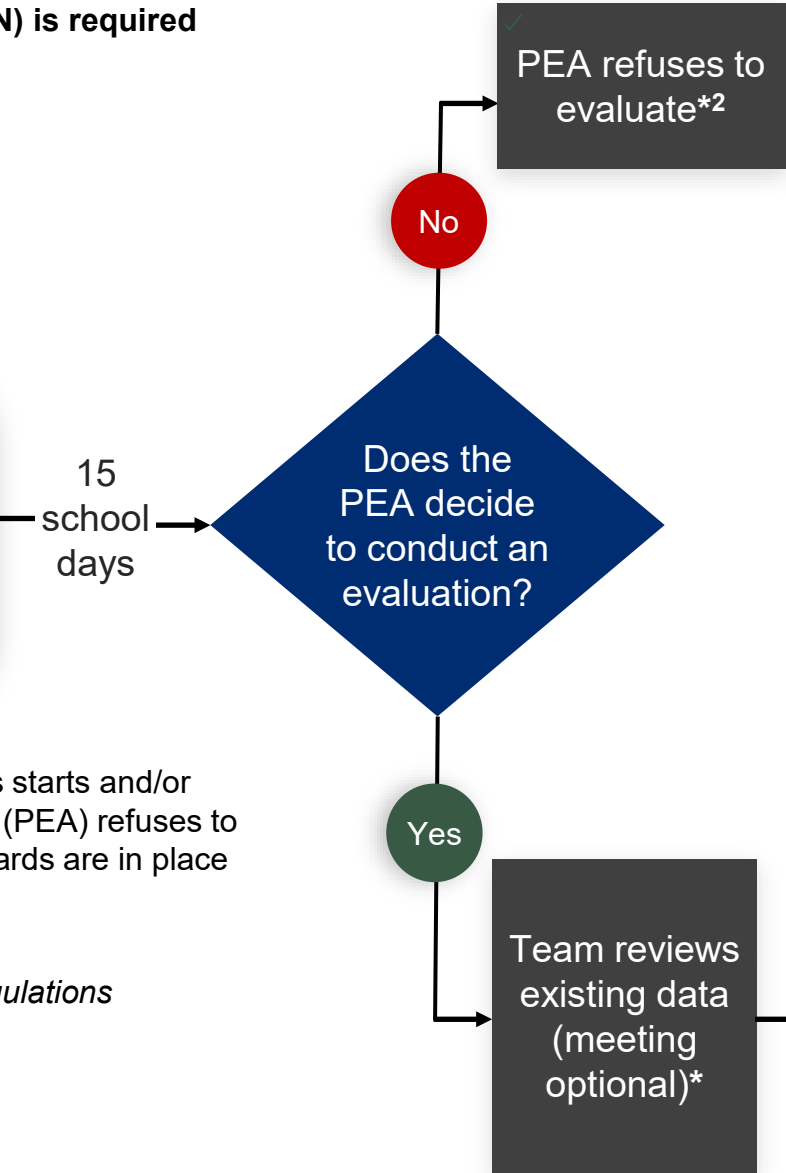

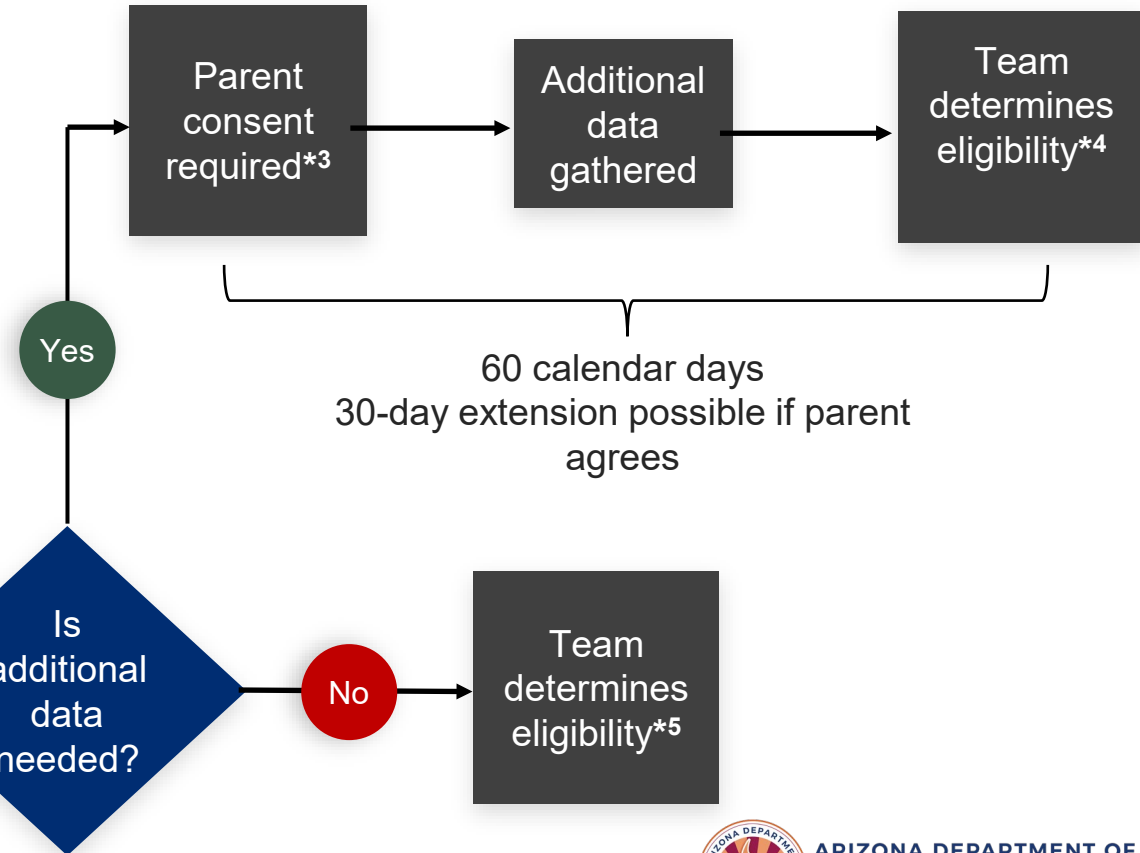


Once the evaluation process starts and/or the public education agency (PEA) refuses to evaluate, procedural safeguards are in place for parental rights.

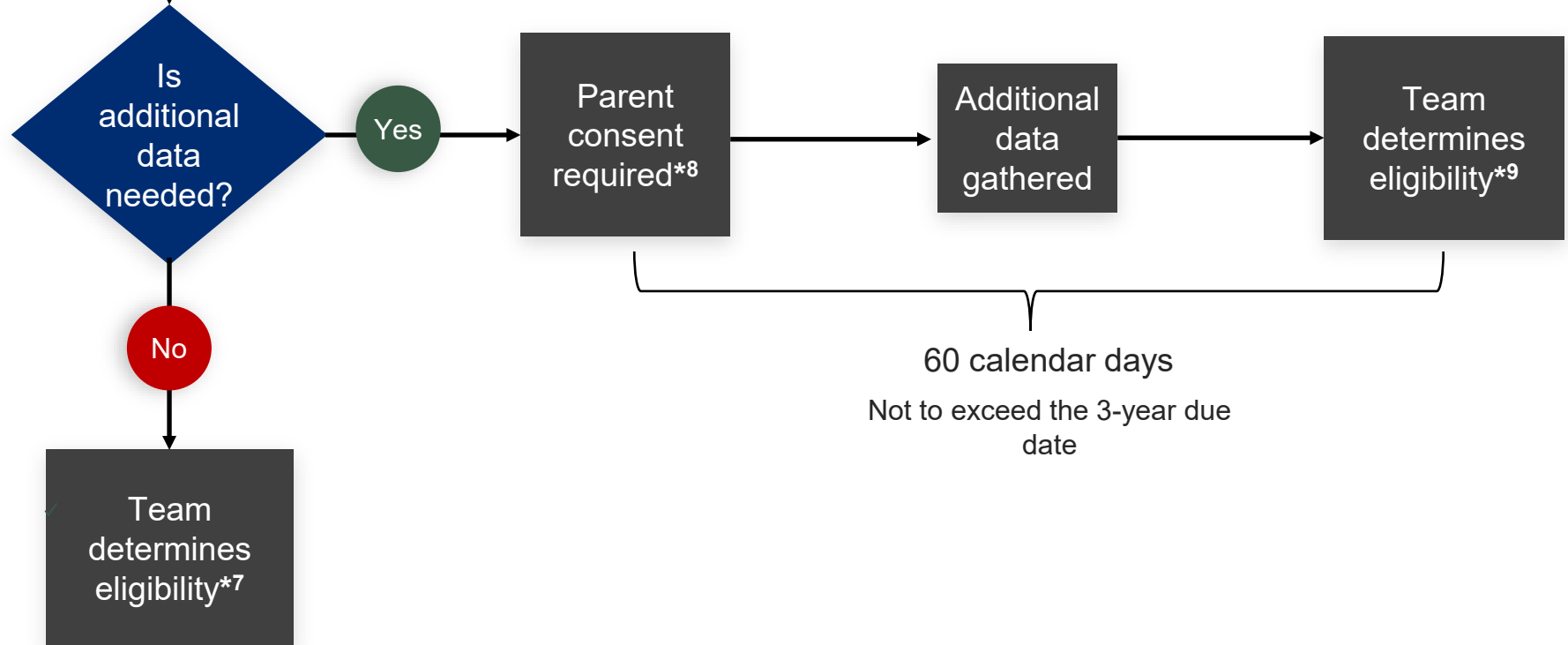


# Reevaluation Flowchart
