



# Identification at the Polls

## *Tribal IDs*

Tribal Identification (ID) and Tribal Documents are valid forms of ID a registered voter may present to receive a regular ballot at a voting location. The look and information available on the ID will vary by Tribe.

Acceptable forms of Tribal ID and Documents include, but are not limited to the following items issued by a Tribe, Tribal Subdivision or the Bureau of Indian Affairs Tribal ID, including Enhance Tribal ID or Tribal Enrollment Card, Home Site Assignment Lease, Permit or Allotment, Grazing Permit, Tribal Elections voter registration card, or Certificate of Indian Blood.

### List 1- (one required)

Acceptable forms of ID with voter's photograph, name, and address. The address must reasonably match the precinct register:

- **Tribal Enrollment Card or Tribal Identification, including Enhanced Tribal IDs**
- Valid Arizona driver license
- Valid Arizona non-operating identification license
- Valid United States federal, state, or local government issued identification

### List 2 - (two required)

Acceptable forms of ID (**no photo**) with voter's name and address. The address must reasonably match the precinct register:

- **Tribal identification, Indian Census Card, Tribal Enrollment Cards or other forms of Tribal Identification or Documents without photo**
- Utility bill of the elector that is dated within 90 days of the date of the election. A utility bill may be for electric, gas, water, solid waste, sewer, telephone, cellular phone, or cable television
- Bank or credit union statement that is dated within 90 days of the date of the election
- Valid Arizona Vehicle Registration
- Property tax statement of the elector's residence
- Arizona Vehicle insurance card
- Recorder's Certificate
- Valid United States federal, state, or local government issued identification, including a voter registration card issued by the County Recorder
- Any mailing to the elector marked "Official Election Material"

### List 3 - (two required)

Acceptable forms of ID, one with photo, one without:

- **Tribal Enrollment Card or other form of Tribal ID without address and one valid item from List 2**
- Any valid photo identification from List 1 in which the address does not reasonably match the precinct register/e-pollbook, accompanied by a non-photo identification from List 2 in which the address does reasonably match the precinct register/e-pollbook
- U.S. Passport or passport card without address and one valid item from List 2
- U.S. military identification without address and one valid item from List 2

**If a Tribal Voter presents insufficient ID to obtain a regular ballot under Lists 1-3, but presents any type of Tribal ID or Tribal Documentation that voter must be issued a provisional ballot (in lieu of a conditional provisional ballot) and does not need to return to confirm their identity.**

Tribal Documents that include a nonstandard address should be found to reasonably match if the county has modified the residence address in the roster or e-pollbook and the city or town on the identification matches the city or town on the roster or e-pollbooks. IDs can include mailing or residential addresses.

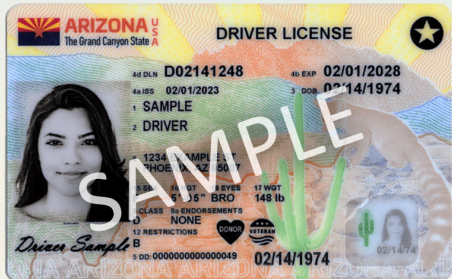

# Identification at the Polls

**Encourage voters to obtain the proper identification.**

**Acceptable forms of ID are listed below**



**AN IDENTIFICATION IS "VALID" UNLESS IT CAN BE DETERMINED ON ITS FACE THAT IT HAS EXPIRED.**

## List 1- (one required)

Acceptable forms of ID with voter's photograph, name, and address. The address must reasonably match the precinct register:

- Valid Arizona driver license
- Valid Arizona non-operating identification license
- Tribal Enrollment Card or Tribal Identification, including Enhanced Tribal IDs
- Valid United States federal, state, or local government issued identification

**If a Tribal Voter presents insufficient ID to obtain a regular ballot under Lists 1-3, but presents any type of Tribal ID or Tribal Documentation that voter must be issued a provisional ballot (in lieu of a conditional provisional ballot) and does not need to return to confirm their identity.**

## List 2 - (two required)

Acceptable forms of ID (**no photo**) with voter's name and address. The address must reasonably match the precinct register:

- Utility bill of the elector that is dated within 90 days of the date of the election. A utility bill may be for electric, gas, water, solid waste, sewer, telephone, cellular phone, or cable television
- Bank or credit union statement that is dated within 90 days of the date of the election
- Valid Arizona Vehicle Registration
- Indian Census Card
- Property tax statement of the elector's residence
- Tribal Identification, Tribal Enrollment Card or other form of Tribal identification or Documents without photo
- Arizona Vehicle insurance card
- Recorder's Certificate
- Valid United States federal, state, or local government issued identification, including a voter registration card issued by the County Recorder
- Any mailing to the elector marked "Official Election Material"

## List 3 - (two required)

Acceptable forms of ID, one with photo, one without:

- Any valid photo identification from List 1 in which the address does not reasonably match the precinct register/e-pollbook, accompanied by a non-photo identification from List 2 in which the address does reasonably match the precinct register/e-pollbook
- U.S. Passport or passport card without address and one valid item from List 2
- U.S. military identification without address and one valid item from List 2
- Tribal Enrollment Card or other form of Tribal ID without address and one valid item from List 2
