#### **Schedule**

Follow the schedule below to complete actions for testing. Pearson communicates with the Administration Test Coordinator (ATC) and will automatically assign that role to the staff member designated with the Arizona Department of Education (ADE) as the Achievement District Test Coordinator. The ATC will assign the roles of Test Coordinator (TC), Room Supervisor (RS), or Technical Coordinator (Tech) within the district or charter. The ATC is responsible for including other staff in activities and training opportunities.
