Target Populations


Students

Who Receives 21st CCLC Funding?

School districts, consortia, charter schools, and other eligible entities serve campuses with 40% or more low-income students.

What is the Minimum/Maximum Amount of Annual Award?

- Annual minimum is \$50,000 per site
- Annual maximum is \$120,000 per site
 - Grants are awarded for five years
