1 Supply chain assistance funds were not used appropriately. Specifically, \$381.35 of Supply Chain Assistance funds were used to purchase the following processed/non-domestic foods: Hummus from Costco, dried pineapple and yogurt covered raisins from the Nutshop.

## **Resource Management**

Discussed that the attestation statement signed by the SFA detailed that the SFA will use Supply Chain Assistance (SCA) funds only for purchasing unprocessed or minimally processed domestic food products and that SFAs are required to maintain purchasing and other related records for review and audit purposes.

SFA provided a plan to spend remaining \$9,269.95 in Supply Chain Assistance funds on milk, fresh fruits, and protein-rich components. Specifically, information provided in the training including the "And Justice For All" poster and nondiscrimination statement were not reflective of current requirements. Additionally, the training provided was specific to the Child and Adult Care Food Program instead of the School Meals Program
