2 Food quantities served at lunch during the review period did not meet minimum amounts required by the meal pattern. Specifically, 7.25 oz eq grain was served on September 9-13, 2024 when 8 oz eq is required weekly at lunch for grades K-8. This was not a repeat finding from the previous cycle and therefore did not contribute toward fiscal action calculations.

3 During the week of review, at least 80% of grains served at lunch were not whole grainrich. Specifically, only 79.31% of grains served at lunch during September 9-13, 2024 were whole grain-rich and only 36.6% of grains served at breakfast during September 9-13, 2024 were whole grain rich. This finding was deemed systemic at brekafst due to enriched products being served at breakfast consistently throughtout the review period.

4 Fluid milk was not available in at least two varieties at breakfast and lunch during the review period. Specifically, only one milk variety was available on September 9, 2024 and September 13, 2024 for breakfast and on September 13, 2024 for lunch. This finding was deemed systemic at breakfast due to only one milk variety being offered twice a week with cereal. This was not a repeat finding from the previous cycle and therefore did not contribute toward fiscal action calculations.
