The purpose of this memorandum is to expand on guidance previously provided by the Food and Nutrition Service (FNS) in SP 18-2009 Equipment Assistance Grants for School Food Authorities (SFAs), dated March 9, 2009, and on SP 20-2009 Equipment Assistance Grants for School Food Authorities - Questions and Answers, dated March 20, 2009.



**SP 07-2025, CACFP 07-2025: REQUIREMENT TO
ACCEPT MEDICAL STATEMENTS FROM
REGISTERED DIETITIANS FOR SCHOOLS AND
CHILD AND ADULT CARE INSTITUTIONS AND
FACILITIES**

The purpose of this memorandum and the attached Questions and Answers (Q&A) is to clarify the updated regulatory requirement for Program Operators to accept medical statements from registered dietitians. This requirement applies to Program Operators of the National School Lunch Program (NSLP) and School Breakfast Program (SBP) (collectively, the school meal programs) and the Child and Adult Care Food Program (CACFP). The change requiring Program operators to accept medical statements from registered dietitians must be implemented by July 1, 2025, for school meal programs and October 1, 2025, for CACFP.

ONSITE MONITORING REQUIREMENT DUE FEB 1

This is a reminder School Food Authorities (SFAs) operating more than one site must conduct internal on-site monitoring prior to Thursday, February 1, 2025.

SFAs operating more than one site are required to conduct on-site reviews of the counting and claiming system and the readily observable areas of review annually at each site prior to February 1. This requirement includes reviews of breakfast and lunch. All lunch sites must be reviewed annually and 50% of breakfast sites must be reviewed annually.

USDA DOD FRESH ANNOUNCES FFAVORS UPDATE

USDA DoD Fresh announced that on January 5, FFAVORS will be updated to have the requirement to receipt in FFAVORS within 2 business days of receipt of produce. This aligns with [ENS Instruction 709-5 Shipment and Receipt of USDA Foods](#), requirement to receipt in WBSCM within 2 business days of receipt of USDA Foods.

This is the message users will see in FFAVORS:

Please Read (updated on 1/5/2025)

The following changes have been made to FFAVORS:

- Customers are now required to receipt within 2 business days of RDD (previously 5 business days) before a receipt is considered past due. As before, if past due receipt(s) exist, ordering will be locked until past due receipt(s) are processed. Receipts will continue to remain on the Edit Receipts screen for 7 days after RDD.

STANDARDIZED RECIPES FOR CNP OPERATORS FROM ICN

Fifteen standardized recipes have been added to the [Child Nutrition Recipe Box \(CNRB\)](#), 7 of which are existing favorites that have been revised to reflect updates from the final rule, “[Child Nutrition Programs: Meal Patterns Consistent With the 2020–2025 Dietary Guidelines for Americans](#)” and 8 new recipes that provide additional ideas for breakfast and lunch menus.

USDA Standardized Recipes provide program operators and menu planners with appealing and practical menu options for the National School Lunch Program, School Breakfast Program, and the Child and Adult Care Food Program.



THE CHILD NUTRITION DATABASE IS NOW AVAILABLE ON FOODDATA CENTRAL!

The Child Nutrition Database (CNDB) has moved from the USDA Food and Nutrition Service website to FoodData Central’s website: fdc.nal.usda.gov/cnbd. The CNDB is the required database for nutrient analysis software approved by USDA for use in school meals. The CNDB includes food product data collected for the following 19 nutrients and components: calories, total fat, saturated fat, trans fat, cholesterol, sodium, carbohydrate, dietary fiber, protein, vitamin A, vitamin C, vitamin D, calcium, potassium, iron, ash, total sugars, added sugars, and moisture. The CNDB includes nutrient data from: USDA National Nutrient Database for Standard Reference (SR) Legacy Release, USDA Standardized Recipes, and food manufacturers for products produced for and marketed to school food service, including USDA Foods.

Determine how many applications will be verified and select the applications using an appropriate sampling method.

PHASE 3: VERIFY - COMPLETE!

Conduct direct verification on the selected applications in CNP Direct Verification, and contact the households that were not directly verified.

PHASE 4: REPORT

Log into ADEConnect to submit the Verification Summary Report (VSR) in CNP Verification Reporting.
