

TEACHER CERTIFICATION GUIDANCE CAREER AND TECHNICAL EDUCATION



Introduction

This guide simplifies and clarifies the varied pathways to CTE teacher certification as stated in the Arizona State Board of Education Rule R7-2-612 (https://azsbe.az.gov/rules).

Applicants seeking CTE Teacher Certification should refer to the Arizona Department of Education Certification Requirements for a complete set of information.



Pathways to CTE Teacher Certification

ADDITIONAL REQUIREMENTS - AT THE TIME OF CERTIFICATION OR WITHIN THREE YEARS

Applicants who otherwise qualify may be issued a Standard CTE certificate with the following allowable deficiencies that must be completed within three years from the date of issuance.

- (1) Complete 15 semester hours of courses in professional knowledge in CTE. This can be ADE CTE-approved PD for certification credit or post-secondary courses.
 (2) Obtain a passing score on the NES Assessment of Professional Knowledge: Secondary or qualify for an assessment waiver.

CTE Teacher Certification Definitions

CTE Field of Study

A field of study refers to experience in one of the following areas: Agriculture, Business and Marketing, Education and Training, Family and Consumer Sciences, Health Careers, or Industrial and Emerging Technologies.

CTE Occupational Area

Occupational area refers to employment in the specific CTE field of study. All options to qualify for a Career and Technical Education (CTE) certificate require verification of work experience in the specific CTE occupational area requested.

Professional Knowledge - Semester Hour Coursework Hours

15 clock hours of ADE CTE approved Professional Development for certification credit = 1 college semester hour of credit.

Professional Knowledge Coursework Requirements

Courses in career and technical education professional knowledge include any one of the following areas:

- Principles/philosophy of Career and Technical Education.
- Developmentally appropriate instructional delivery.
- Facilitation and methodologies for Career and Technical Education.
- Instructional technology.
- Instructional design, and lesson planning to include modifications accommodations, assessing, monitoring, and reporting progress.
- The learning environment to include classroom management.
- Teaching students with exceptionalities.
- Professional responsibility and ethical conduct.

Industry associations, professional organizations, postsecondary institutions, CTEDS, districts, and schools can apply to offer professional knowledge courses that are approved for professional knowledge certification credit.



CTE Teacher Certification Definitions, cont.

Subject Knowledge

The information, understanding, and skills specific to the CTE occupational area.

Verified Work Experience

Work experience documentation is completed by an HR Administrator, Supervisor, or Current Superintendent. The performed work experience in the CTE occupational area reflects the knowledge or skill relevant to a CTE program occupational area in Agriculture, Business and Marketing, Education and Training, Family and Consumer Sciences, Health Careers, or Industrial and Emerging Technologies.

ADE CTE Certification Occupational Areas (note: this is not an all-inclusive list)

"Agriculture" means occupations related to work experience in Agriculture Operations and related Sciences; Agricultural Mechanization; Agricultural and Food Products Processing; Agricultural Public Services; Agricultural Biological Engineering; Agricultural and Domestic Animal Services; Animal Sciences; Forest Engineering, Food Science and Technology; Natural Resources and Conservation; Landscape Architecture; Biological and Biomedical Sciences; Plant Sciences, Soil Sciences, and Horticulture; Veterinary/Animal Health Technician/Veterinary Assistant; and Veterinary Medicine as described in NCES Classification of Instructional Programs (CIP) 2020 Edition: CIP Code 01, which is incorporated by reference* and on file with the Arizona Department of Education and the Office of the Secretary of State.

"Business and Marketing" means occupations related to work experience in Accounting; Business/Commerce; Business Administration and Management; Business Operations Support and Assistant Services; Business/Corporate Communications; Finance and Financial Management Services; Hospitality Administration/Management; Human Resources Management and Services; Management Information Systems and Services; Marketing; Real Estate; Taxation; Insurance; and Merchandising and Related Marketing Operations as described in NCES Classification of Instructional Programs CIP 2020 Edition: CIP Code 52, which is incorporated by reference* and on file with the Arizona Department of Education and the Office of the Secretary of State.

"Education and Training" means occupations related to work experience in Early Childhood Education and Teaching (Birth-3rd grade); Preschool/Kindergarten Education Teaching (4K-K); Elementary Education Teaching (K-5th grade); Junior High/Intermediate/Middle School Teaching (6-8th grade); Secondary Education Teaching (9-12th grade); Special Education and Teaching (K-12th grade); and Adult and Continuing Education Teaching (Secondary credit recovery/GED) as described in NCES <u>Classification of Instructional Programs</u> (CIP) 2020 Edition: CIP Code 13, which is incorporated by reference* and on file with the Arizona Department of Education and the Office of the Secretary of State.

"Family and Consumer Sciences" means occupations related to work experience in Culinary Arts; Food and Nutrition Sciences; Childcare Provider (Birth-12th grade); Early Childhood Education and Teaching (Birth-3rd grade); Kindergarten/Preschool Education Teaching (4K-K); Fashion/Apparel Design; Apparel and Textiles; Interior Design; Hospitality Administration/ Management; and Family and Consumer Sciences/Human Sciences Teaching (K-12th grade) as described in NCES <u>Classification of Instructional Programs (CIP)</u> 2020 Edition: CIP Codes 13,19, 26, 50, 52 which is incorporated by reference* and on file with the Arizona Department of Education and the Office of the Secretary of State.
