#### **Program Reminders**

- 3rd Quarter Grant Award Reimbursement Requests: Remember to regularly draw down your program's FY 2025 Adult Education awarded funds. Please Note: Fiscal Monthly Reports are available (by the 15th) in your program's LEA Document Library. Contact janice.cruz@azed.gov with questions.
- Review budgets and expenditures regularly and submit funding application revisions as needed. Deadline to submit budget revisions is June 30, 2025 (<u>2 CFR 200.211</u> (b)(5) and (b)(6)). No exceptions.
- GME Virtual Technical Assistance is available with your assigned Grants Coordinator to assist with submitting Reimbursement Requests, Completion Reports, or other

- processing needs. Please contact 602-542-3901, option 2, to schedule a virtual technical assistance session.
- February Grants Management Enterprise (GME) trainings are available in <u>APLD</u> or visit the <u>ADE Grants Management Enterprise (GME)</u> for detailed training or grants information.

#### **FY2026 GME Required Supplements**

- General Statement of Assurances (GSA) are due on March 1, 2025. The FY26 GSA
  has a new section which requires an upload of your organization's organizational
  chart.
- Self-Assessment due March 1, 2025. The purpose of the self-assessment is to capture
  grantee information required to accept and use Federal grant funds. The supplement
  consists of five sections with measures to assist the grantee in evaluating performance
  and compliance with Federal grant requirements.
- Indirect Cost (IDC) has a new timeline. Now available only through June 30, 2025.
  - Please Note: counties, colleges, and other government entities must request to be added to the <u>Indirect Cost – Counties</u>, <u>IHEs</u>, <u>Other Gov't</u> supplement by sending a request to GME Help Desk. Once added, the entity may apply for IDC directly through the <u>Indirect Cost – Counties</u>, <u>IHEs</u>, <u>Other Gov't</u> supplement.
